

2018 SCI CONVENTION TAKE YOUR BEST SHOT SWEEPSTAKES OFFICIAL RULES
NO PURCHASE OR CONTRIBUTION NECESSARY TO WIN
A PURCHASE OR CONTRIBUTION WILL NOT IMPROVE YOUR CHANCES OF WINNING

Eligibility. Open only to legal residents of the 50 United States and District of Columbia who are 18 or older at the time of entry. Employees of Safari Club International ("SCI" or "Sponsor"), individuals or entities involved in the implementation and execution of the Promotion, and members of their immediate family or household are not eligible. Void where prohibited, taxed, or restricted. This "Take Your Best Shot" Sweepstakes is conducted in the United States and is governed by applicable US law.

HOW TO ENTER. This Take Your Best Shot Sweepstakes ("Sweepstakes") begins on or about 10:00 am Pacific Time (PT) on January 31, 2018, and ends at 3:00 pm Pacific Time (PT) on February 03, 2018 ("Sweepstakes Period"). There are two (2) ways to enter: (1) during the Sweepstakes Period, contact an SCI representative at SCI's 2018 Annual Hunters Convention at the Las Vegas Convention Center in Las Vegas, Nevada ("Convention") to make suggested contribution of \$40 (US) to SCI and receive one entry into the drawing; make a suggested contribution of \$100 (US) and receive three entries into the drawing; make a suggested contribution of \$300 (US) and receive twelve entries into the drawing; or (2) To obtain one (1) free entry by email, send an email to sweepstakes@safariclub.org. You must include "2018 SCI Convention Take Your Best Shot Sweepstakes Entry" in the subject line of the email, and include your name, address, age and daytime phone number in the body of the email. Limit twelve (12) entries per person, regardless of method of entry. **Contributions are not tax deductible donations.** Any use of robotic, repetitive, automatic, programmed, or similar entry methods or agents (including, but not limited to sweepstakes entry services) are prohibited and will void all entries by that entrant. All entries regardless of method, must be received by Sponsor during the Sweepstakes Period. Entrant assumes risk of loss, damage, destruction, delay and misdirection of entries, and is solely responsible for postage due, illegible or incomplete entries. Once submitted, entries become the sole property of Sponsor and will not be returned. The makes, models and features of each firearm will be determined by Sponsor in its sole discretion, and will vary by firearm. The approximate retail value (ARV) of each firearm will vary, ranging from \$500 to \$1,250. Sponsor will pay estimated income tax on any prize valued over \$5,000 and the amount paid for winner's taxes will be added to the ARV of that prize. Prizes will be awarded in the order determined by Sponsor in its sole discretion. In order to receive a firearm prize, winners must be eligible for firearms possession, must comply with all applicable local, state and federal regulations and must make arrangements for delivery of firearms if included in the package won with appropriate federally licensed firearms dealers as required by state, federal/provincial law.
