

**2018 SCI CONVENTION SUPER SWEEPSTAKES OFFICIAL RULES**  
NO PURCHASE OR CONTRIBUTION NECESSARY TO WIN  
A PURCHASE OR CONTRIBUTION WILL NOT IMPROVE YOUR CHANCES OF WINNING

**Eligibility.** Open only to legal residents of the 50 United States and District of Columbia who are 18 or older at the time of entry. Employees of Safari Club International ("SCI" or "Sponsor"), individuals or entities involved in the implementation or execution of the Promotion and members of their immediate family or household are not eligible. Void where prohibited, taxed, or restricted. This Super Sweepstakes is conducted in the United States and is governed by applicable US law.

**HOW TO ENTER.** This Super Sweepstakes ("Sweepstakes") begins on or about 10:00 am Pacific Time (PT) on January 31, 2018, and ends at 4:00 pm Pacific Time (PT) on February 03, 2018 ("Sweepstakes Period"). There are two (2) ways to enter: (1) during the Sweepstakes Period, contact an SCI representative at SCI's 2018 Annual Hunters Convention ("Convention") at the Las Vegas Convention Center in Las Vegas, Nevada to make suggested contribution of \$20 (US) to SCI and receive one entry; make a suggested contribution of \$100 (US) to SCI and receive six entries + 1 Bonus entry; make a suggested contribution of \$200 to SCI and receive fifteen entries + 2 Bonus entries; make a suggested contribution of \$300 (US) to SCI and receive twenty five entries + 3 Bonus tickets; make a suggested contribution of \$500 (US) to SCI and receive 50 entries + 5 Bonus entries; make a suggested contribution of \$1,000 (US) to SCI and receive 100 entries + 15 Bonus entries; or make a suggested contribution of \$2,000 (US) to SCI and receive 225 entries +30 Bonus entries; Once you have obtained your entry tickets, you must deposit them in one or more of the ten (10) prize drums at the Convention, depending on the prize drawing(s) you wish to enter; or (2) during the Sweepstakes Period, obtain twenty-five (25) free entries by email, by sending an email to [sweepstakes@safariclub.org](mailto:sweepstakes@safariclub.org). You must include "2018 SCI Convention Super Sweepstakes Entry" in the subject line of the email, and include your name, address, age and daytime phone number in the body of the email, with instructions as to which prize drum(s) to deposit your entries in. To obtain three (3) free Bonus entries by email, send an email to [sweepstakes@safariclub.org](mailto:sweepstakes@safariclub.org). You must include "2018 SCI Convention Super Sweepstakes Bonus Entry" in the subject line of the email, and include your name, address, age, and daytime phone number in the body of the email, with instructions as to which prize drum(s) to deposit your Bonus entries in. Limit 225 entries and 30 Bonus entries per person, regardless of method of entry. **Contributions are not tax deductible donations.** Any use of robotic, repetitive, automatic, programmed, or similar entry methods or agents (including, but not limited to sweepstakes entry services) are prohibited and will void all entries by that entrant. **Drawing.** Super Sweepstakes winners will be selected in random drawings on or about February 03, 2018 from eligible entries received for each prize drum. You do not need to be present to win. The drawings will be conducted by a Sponsor representative. Sponsor's decisions are final and binding in all respects.

**Prizes/Odds of Winning.** There are ten (10) separate prize drawings offered in the Super Sweepstakes, each consisting of either a hunt, firearm or optics. The prize elements, models, features and all other details or merchandise included in any of the prizes will be determined by Sponsor in its sole discretion, and will vary by item. Sponsor will pay estimated income tax on any prize valued over \$5,000 and the amount paid for winner's taxes will be added to the ARV of that prize. In order to win a firearm prize winners must be eligible for firearms possession, must comply with all applicable local, state and federal regulations and must make arrangements for delivery of firearms, if included in the prize package, with appropriate federally licensed firearms dealers as required by state and federal law. Firearms prizes will not be shipped to any state where such prize is prohibited by law. In the event a winner resides in a state where firearms prizes cannot be shipped or where such prize is prohibited by law, that winner will receive a prize of \$500 in lieu of a firearm, delivered in the form of a check.
